### **END USER LICENSE AGREEMENT (EULA)**

By downloading, installing, or using this font, you agree to be bound by the terms and conditions of this End User License Agreement (EULA). If you do not agree to these terms and conditions, do not continue to install or use the font.

### **LICENSE GRANT**

This font is licensed to you, not sold. So Marvadesign grants you a non-exclusive, non-transferable right to use this font within the limitations set forth below:

### **INSTALLATIONS**

Use of the Font Software is limited to the number of End Users identified when this License is purchased. The Font Software may be installed on no more than two (2) computers (a workstation and a laptop, iPad or other portable device used in lieu of a workstation-type computer for each licensed End User), provided that both computers are not used simultaneously. For clarity purposes, Licensed End Users may install the Font Software on their laptop, iPad or other portable device and their workstation, provided that both are not used at the same time. Serving the Font Software to Unlicensed End Users over a network, LAN, WAN, or the Internet is strictly prohibited.
